## Liquor License Application

1. Name, age and address of the applicant. If applicant is a corporation, in place of age include the objects for which the corporation is organized, the names and addresses of the officers and directors of the corporation. If a majority interest of the stock of such corporation is owned by one person or his nominee include the name and address of such person; in the case of a partnership, the persons entitled to share in the profits should be included.
2. The citizenship of the applicant, his place of birth, and if a naturalized citizen the time and place of his naturalization.
3. The character of the business of the applicant and in the case of a corporation the objects for which it was formed.
4. The length of the time the applicant has been in business of that character, or in the case of a corporation, the date on which its charter was issued.
5. The amount of goods, wares and merchandise on hand at the time the application is made.
6. The location and description of the premises, or place of business which is to be operated under this license.
7. A statement whether the applicant has made applications for a similar or other license on the premises other than described in the application, and the disposition of the application.

8. The applicant herein will not allow gambling devices on the premises.

9. The applicant herein has never been convicted of a felony and is not disqualified to receive a license by the reason of any matter or things contained in the Onarga Liquor Ordinances, the Onarga Village Code, Laws of the state of Illinois or of the United States of America.

10. If a previous license by any state or subdivision or by the federal government has been revoked, please state the reasons for such revocation.

11. The applicant will not violate any of the laws of the State of Illinois, or of the United States of America, or any ordinances of the Village of Onarga in the conduct of his place of business.

12. The applicant has not received or borrowed any money or anything else of value and the applicant will not receive or borrow money or anything else of value directly or indirectly from any manufacturer, importing distributor or distributor or representative of any of them except as may be provided by the Illinois Revised Statutes, Chapter 43.

13. The undersigned hereby makes application for issuance of a liquor license by the Village of Onarga and agrees to comply with all provisions of said license and all liquor ordinances of the Village of Onarga and the Onarga Village Code. The undersigned applicant understands that said license may be suspended or revoked for cause if the applicant violated any provisions of said license, ordinance or code.

## Village of Onarga Municipal Code

### 5.20.060 Classifications

A. Liquor licenses are divided into the following classes:

1. Class A licenses, which shall authorized the retail sale on the premises specified of all alcoholic liquor including beer and wine, for consumption on or off the premises. The annual fee for such licenses shall be seven hundred dollars (\$700.00).

2. Class B licenses, which shall authorize the retail sale on the premises specified of all alcoholic liquor beer and wine, for consumption off the licensed premises only. The annual fee for such licenses shall be seven hundred dollars (\$700.00).

3. Class C licenses, which shall authorize the retail sale on the premises specified of all alcoholic liquors including beer and wine for consumption on the licensed premises only, but the licensee shall not be permitted to have a bar nor shall the licensee be permitted to have any live entertainment of the kind and character which would require an admission tax to be paid to the Internal Revenue Service. The annual fee for such licenses shall be seven hundred dollars (\$700.00).

4. Class D licenses, which shall authorize the retail sale on the premises specified of beer and wine only, but only for consumption off licensed premises. The annual fee for such licenses shall be five hundred dollars (\$500.00).

5. Class G licenses, which shall authorize the retail sale on the premises specified of beer and wine only, and only for consumption on the licensed premises and only during the twenty-four (24) hour period indicated on the face of the license. The special fee for such license shall be fifty dollars (\$50.00). A Class G license shall be valid only for twenty-four (24) hours and the issuing authority is directed to indicate the twenty-four (24) hour period on the face of the license during which such sale of alcohol shall be valid by the licensee. The holder of such Class G license shall be subject to the same closing hours as may be indicated for other license holders under this liquor code. The holder of such license shall not permit the sale of any alcoholic liquor except between the hours permitted by the twenty-four (24) hour license defined above and except as may be allowed by the closing hour time limits defined in this code.
